2. Release of Liability

a. I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY/ALL ACTIVITIES ASSOCIATED WITH THIS EVENT, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective

- equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.
- b. I certify that the delegate is physically fit, has sufficiently prepared or trained for participation in this activity, and has not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude his or her participation in this activity.
- c. I acknowledge that this waiver will be used by the event holders, sponsors, and organizers of the activity in which the delegate may participate, and that it will govern his/her actions and responsibilities at said activity.
- d. I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from BELLARMUN.
- e. I acknowledge that BELLARMUN and their secretariat members, representatives, and agents are NOT responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.
- f. I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity.

3. Authorized Persons for pick-up

- a. For the safety of all delegates attending BELLARMUN 2023, a delegate may only be released from BELLARMUN to a person authorized to pick up the delegate.
- b. People who are authorized to pick up the delegate include their legal parents/guardians, and those listed as their emergency contact during registration. If another person must pick-up a delegate from the conference, they must be authorized by contacting the Secretary-General of BELLARMUN via email at sg@bellarmun.org.
- c. Any person who picks up a delegate must be able to present legal photo identification upon request.
- d. In the case that a delegate is unable to be picked up by an authorized person, the delegate's parent listed on their initial registration will be called. If they are unreachable, their emergency contact will be called.

4. BELLARMUN 2023 and Bellarmine Preparatory School reserve the right to remove individuals in violation of this agreement from the conference.

a. Delegates who are found in violation of the rules outlined in the Student Conduct Agreement or in the provisions in this document may be dismissed from participation from the conference. In this case, the delegates parents or legal guardians will be contacted and asked to immediately remove their delegate from Bellarmine Preparatory Campus. Once the initial phone call has been made to the parents/legal guardians, BELLARMUN will remain as the supervisor of the delegate until an authorized person arrives.

5. Misconduct

- a. In order to maintain a professional and safe environment, I will not engage in any form of physical or verbal abuse or bullying. Furthermore, should any abuse or bullying occur, the BellarMUN program Advisor must be contacted immediately.
- b. Pursuant to the Bellarmine Student Handbook, I will not engage in or threaten to engage in any form of sexual misconduct. The result of such an action would be immediate removal from BELLARMUN and a formal report filed with the Bellarmine Dean of Students.
- c. Plagiarism will not be tolerated under any circumstances and all materials that I submit will be vetted through Turnitin.com by the Advisor. No materials created or published by MUN Northwest, or any of its subsidiaries, may be used by BELLARMUN. Use of these materials, in any way, will be considered plagiarism and would be considered grounds for dismissal from the Secretariat. I understand that all instances of plagiarism will be thoroughly investigated and a report will also be sent to the Bellarmine Dean of Students.
- d. Pursuant to the Bellarmine Student Handbook, I will not be under the influence of, or use, sell, distribute or possess tobacco, drug paraphernalia, dangerous or controlled substances or any substances purported to be such, except drugs prescribed by a physician or other person authorized to prescribe drugs for my personal use. If I am required to possess or use prescription drugs, I shall notify the Dean of Students prior to possessing or using them at any BELLARMUN event. Dangerous or controlled substances and substances purported to be such, include, but are not limited to, narcotics, amphetamines, marijuana, hallucinogens, barbiturates, vapes, E-Cigarettes, Juuls, prescription or non-prescription drugs of any nature and medications such as diet pills and caffeine pills. All tobacco, alcohol, drug paraphernalia, and drugs in my

- possession, except drugs prescribed for use as set forth above, shall be confiscated by a Bellarmine faculty member. Vaping paraphernalia will be considered drug paraphernalia under RCW 69.50.102.
- e. To eliminate distractions and encourage positive debate, during all workshops and committee sessions, mobile devices may not be used and must be silenced. BELLARMUN recognizes the importance of using technology while researching and therefore provides delegates with laptops to use during the research workshop. Any use of technology at the conference outside of the defined parameters will result in the Secretariat being notified to evaluate the situation and respond appropriately.
